



Nooitgedacht Estate & Warren-Stone Weddings and Events Terms & Conditions Compilation

GENERAL:

- All images and video footage captured during the planning process and the wedding celebration can be used as marketing material by the competition sponsors
- Should the couple call off their engagement or cancel the wedding for any reason the sponsors will be notified, and all sponsorship withdrawn. The value of the prize cannot be exchanged for a cash prize nor designated to a different celebration
- The couple will provide a three-month period during the 2019 year in which they would like to get married
- The wedding sponsors will provide a mutually available date within that three month period which will then be presented to the couple within a week of the winner announcement
- Images used within the Win a Wedding marketing campaign are not accurate representations of the products and services included within the prize

NOOITGEDACHT ESTATE:

- Venue will only be available until midnight
- Setup will only be available on the day of the wedding from 08h00
- The one glass of wine stipulated above can either be red or white
- Menu starter options include: Biltong salad, Bacon Pastry, Soup, Mushroom Risotto or any Vegetarian option
- Menu main options include: Confit of Lamb, Fish, Duck, Pork Belly or any Vegetarian options
- Both starter and main courses include a choice of three options ahead of the wedding date or a fixed choice on the night of the wedding
- Furniture to be used in pre-drinks area:
- 6 Cocktail tables
- 6 Naked tables, 4 pre-drink tables and 4 coffee tables
- Wooden bar structure
- White half circle bar structure
- 3 Large umbrellas for pre-drinks
- 4 White slate garden benches
- 8 Pallet benches
- 3 Wine barrels
- Reception furniture includes the foyer furniture, rectangular tables, white tiffany chairs, cutlery, crockery and glassware
- For the accommodation check in is at 11h00 and check out is at 10h00. The bride and her bridesmaids may get ready at the Manor House during this period
- Catering for breakfast may be included at an additional fee
- The value of the prize cannot be exchanged for a cash prize
- Date of wedding to be finalized by no later than 14th of March and it will be based on a mutually available date confirmed by all sponsors



WARREN-STONE WEDDINGS AND EVENTS:

- The planning process will begin 6 months before the confirmed wedding date
- Appointments during the planning process to be held either telephonically or personally during office hours, Monday - Friday between 09h00 and 17h00
- All personal meetings to be held within the Somerset West or Cape Town central area
- Any additions to the sponsors prizes should be liaised with Warren-Stone Weddings and not with the supplier directly
- Any additional suppliers incorporated within the celebration should be liaised and managed by the couple until one week prior to the wedding. Thereafter Warren-Stone Weddings will manage their services on the day of the wedding.
- A representative from Warren-Stone Weddings to be present on the wedding day between 08h00 and 22h00
- 100-word reference required from the winning couple detailing how they found the coordination process
- Full access to the wedding video and photographs to be used for marketing material
- Documentary style photographs will be taken by the Warren-Stone Weddings team throughout the planning process to share on social media
- Date of wedding to be finalized by no later than 14th of March and it will be based on a mutually available date confirmed by all sponsors
- The value of the prize cannot be exchanged for a cash prize

G STUDIO:

- Winning couple to send inspiration images to G Studio prior to design work commencing
- A maximum of 3 reverts are included within the prize, additional changes will be billed accordingly
- The value of the prize cannot be exchanged for a cash prize
- Date of wedding to be finalized by no later than 14th of March and it will be based on a mutually available date confirmed by all sponsors

NCONCEPTS AND DESIGNS:

- Gazebo include draping if they want, white gazebo, white or wooden arch, wooden geo arch or round circle arch
- Chairs can be white tiffany and white or wooden wimbledon
- Table cloths can be white, grey or stone rectangles
- Napkins can be white, grey, stone or navy
- Underplates can be plain glass, plain gold, glass with gold rim or round wooden
- Tea light candles of different colours
- Votives and candle holders of different colours
- Vases of different colours for guest tables
- Vases of different colours for bridal table
- Lighting options include fairy lights, naked bulbs, chandeliers or white fringe lights
- Draping includes white draping in assorted style options
- The value of the prize cannot be exchanged for a cash prize



MABEL M FLORAL:

- The vases that are used from Mabel M Florals stock room should be stored correctly over night for collection the morning after the wedding takes place
- The value of the prize cannot be exchanged for a cash prize
- Date of wedding to be finalized by no later than 14th of March and it will be based on a mutually available date confirmed by all sponsors

YES! EXCLUSIVE FLOWERS:

- The choice of floral is subject to availability
- The quantity of floral will be mentioned per vase and not per stem count
- The floral look, table layout and table design is to be finalised no later than 2 months prior to the wedding to ensure sufficient floral ordering time is included
- All Yes! Flower produce is subject to their T's and C's that can be found on their website www.yes-flowers.info
- The value of the prize cannot be exchanged for a cash prize
- Date of wedding to be finalized by no later than 14th of March and it will be based on a mutually available date confirmed by all sponsors

TROUES IN DIE WYNLAND:

- Bride and Groom box may not be exchanged for additional stationery
- All stationery will be full color printing only (Foiling, engraving and laser cutting is not included)
- A1 Seating chart easel is available in either light wood, dark wood or perspex
- Name cards can be tented, flat name card only
- Menu can be A5 or DL size printed in full color
- Satin gown available in assorted colors and sizes
- Swarovski pen available in assorted colors
- The value of the prize cannot be exchanged for a cash prize
- Date of wedding to be finalized by no later than 14th of March and it will be based on a mutually available date confirmed by all sponsors

CAKES BY WADE:

- 5 tier cake of which 3 tiers are real cake and the bottom 2 are dummy cake
- Flavour options include chocolate, vanilla, coffee, red velvet or lemon and poppy seed
- Sugar floral included on a maximum of 2 tiers
- Date of wedding to be finalized by no later than 14th of March and it will be based on a mutually available date confirmed by all sponsors
- The value of the prize cannot be exchanged for a cash prize

GORGEOUS 2 GO:

- Sponsorship extends to the bride only, does not include any family members or bridesmaids
- After winner of competition has been chosen, the bride is to send through the desired look she wants as to let the make-up artists pack the correct equipment
- Bride must take photos of completed make-up and tag Gorgeous 2 Go
- The value of the prize cannot be exchanged for a cash prize
- Date of wedding to be finalized by no later than 14th of March and it will be based on a mutually available date confirmed by all sponsors

BRONWYN TOD PHOTOGRAPHY:

- A 50 image sneak will be sent through two weeks after the wedding
- The full album will be released between six to eight weeks after the wedding
- Date of wedding to be finalized by no later than 14th of March and it will be based on a mutually available date confirmed by all sponsors
- The value of the prize cannot be exchanged for a cash prize

SECOND LUKE:

- The content of the package is final. If additional hours of filming are required on the day- an additional invoice will be sent to the couple after the wedding.
- Secondluke Films will not use any commercial music for the film. Music will be licensed on Musicbed. These songs will be chosen by Secondluke Films and cannot be changed.
- Secondluke Films hold the rights to the raw footage. Raw footage will not be given to the couple.
- The couple is responsible to provide dinner for two videographers on the wedding day.
- The couple is responsible to send the final timeline (As discussed with the Photographer and Warren-Stone Weddings) to Secondluke Films 7. Secondluke Films will not be held responsible for any moments missed because of
 - o the weather and any acts of God
 - o the timeline running late
 - o the photographer/ any guests with cameras or cellphones that blocked our view.
- The product sent to the couple (After four months) is final and no re-edit will be done.
- The value of the prize cannot be exchanged for a cash prize

RICKY H:

- A maximum of 10 hour set is included within the prize value
- An overtime rate of R4000 will be charged per hour over and above the 10 hours
- An overtime rate of R4000 will be charged per hour after midnight
- All sound equipment for ceremony, pre-drinks and reception will be provided
- Dance floor lighting will be provided for reception venue
- Date of wedding to be finalized by no later than 14th of March and it will be based on a mutually available date confirmed by all sponsors
- The value of the prize cannot be exchanged for a cash prize



GERRY LIBERTY:

- The performance will need to be in one location
- Sufficient light will need to be provided should the performance take place at night
- The value of the prize cannot be exchanged for a cash prize
- Date of wedding to be finalized by no later than 14th of March and it will be based on a mutually available date confirmed by all sponsors

CHANTELLE BOSHOFF:

- Maximum of 5 dress fittings included within the prize
- The value of the prize cannot be exchanged for a cash prize
- Date of wedding to be finalized by no later than 14th of March and it will be based on a mutually available date confirmed by all sponsors

WEEF:

- Sponsorship extends to any size, style and color within the Weef tie range
- Date of wedding to be finalized by no later than 14th of March and it will be based on a mutually available date confirmed by all sponsors
- The value of the prize cannot be exchanged for a cash prize

GREEF ATTORNEYS:

- Bride is to be given a reference code to use as to ensure it is the competition winner from Nooitgedacht
- The value of the prize cannot be exchanged for a cash prize
- Date of wedding to be finalized by no later than 14th of March and it will be based on a mutually available date confirmed by all sponsors
